

**WAKE FOREST UNIVERSITY SCHOOL OF LAW  
FAMILY EDUCATION RIGHTS AND PRIVACY ACT OF 1974  
"FERPA" CONSENT FORM**

In accordance with the Family Education Rights and Privacy Act of 1974 ("FERPA"), it is the policy of the Law School generally to maintain the confidentiality of students' education records, and not to release these records to third parties unless the student consents in advance or release is authorized by FERPA. Students are furnished with a statement of rights under FERPA in the School of Law Bulletin and should refer to this statement for more complete information about those rights.

FERPA restricts the release of information contained in educational records with a number of exceptions. Students may provide additional restrictions on the release of information or may authorize the School of Law to release information that is not otherwise publishable. This form permits you to give your consent for the release of specified records that may assist you in making applications or be of benefit to you for other purposes. This form also permits you to limit the release of directory information about you. This form does not restrict the release of information as provided by FERPA; it does, however, permit you to authorize the release of information that cannot otherwise be released without your consent.

**If you choose not to consent to the release of these educational records, the School of Law cannot assume responsibility to contact you for subsequent permission to release this information. Regardless of the effect upon you, the School assumes no liability for honoring your instructions that such information be withheld. If you subsequently desire the release of information, you must complete a release form.**

I am aware of my rights to protect the release of my education records. I authorize the Wake Forest University School of Law to release my education records as follows:
